

Terms & Conditions

- 1. **HSBC x Lazada 11.11 Sale** ("Promo") is open to HSBC Visa credit cardholders whose cards are issued in the Philippines ("Cardholder/s") and are in good credit standing during the Promo Period. HOW TO AVAIL

- 1. Download the Lazada app for free via App Store for Apple users or Google Play store for Android users.
- 2. Collect the discount voucher on the Promo Page.
- 3. Select the item/s you wish to purchase then click "Add to Cart". Prepare your card details for the transaction.
- 4. Click the Shopping Cart icon on the right, topmost portion of the screen to view all the items on your Shopping Cart.
- 5. Select the item/s you wish to purchase and once you have reviewed the items on your Shopping Cart, click "Check Out".
- 6. Enter your shipping and billing information and select the credit card as payment method.
- 7. Enter your HSBC Visa Credit Card details and make sure to check if the discount was applied to total billing before proceeding to place the order.
- 8. Click "Place Order" to complete the transaction.
