



Terms & Conditions

1. **HSBC Installment Spend Promo with Stores Specialists, Inc (SSI)** ("Promo") is open to HSBC Visa primary credit cardholders whose cards are issued in the Philippines ("Cardholder/s") and are in good credit standing during the Promo Period. For avoidance of doubt, an HSBC credit card is in good credit standing if there is no reason for HSBC to restrain, suspend, cancel, withdraw or terminate the card pursuant to the HSBC Card Terms and Conditions as well as Legal and Compliance Policy considerations.

6. HSBC 0% Credit Card Installment Plan can be applied to transactions subject to minimum spend requirement per merchant.
7. Cardholders must settle payment with their HSBC Visa Credit Card to enjoy the Offers.
8. Installment transactions must be posted to earn rewards. This will include valid transactions of the Supplementary Cardholder linked to the Primary Cardholder's account.
9. The following are defined as excluded transactions:
 - a. Splitting of transactions - Only one (1) qualified HSBC Credit Card may be used per single-receipt transaction, and only one (1) qualified HSBC Credit Card may be accepted per Cardholder.
 - b. Installment transactions made outside the Promo Period.
10. Each merchant 0% installment transaction shall be considered as one transaction amount. Succeeding monthly amortizations from the same merchant 0% installment transaction shall not be counted as a separate transaction amount on the Cardholder's account.
11. Transactions of the Primary Cardholder and Supplementary Cardholder/s shall be identified and verified through HSBC's system.
12. An SMS notification with the SSI eGCs shall be sent weekly to the Primary Cardholder every Friday for verified transactions posted within the week. Cardholders may claim their FREE SSI eGCs by accessing the eGC link and by following the merchant's instructions on how to redeem the eGC. SSI eGCs usage guidelines and mechanics apply.
13. Redemption is until **January 31, 2025** for rewards earned from qualified transactions made during the Promo Period.
14. Earned rewards can be used at SSI stores of the listed brands in the Appendix.
15. The cost of Rewards shall be charged to the Cardholder's Credit Card account if claimed through means, which are later found to be invalid or if the Cardholder does not adhere to the stipulated Terms and Conditions of this Promo.
